## CALL FOR THE BECA COLOMBIA SCHOLARSHIP PROGRAM FOR FOREIGNERS

# 2022-II

Be one of the foreigners who can access reciprocity scholarships for postgraduate studies in Colombia  
 100% of the tuition fee for the duration of the academic program.



**Health Insurance:**  
Medical and hospital assistance in Colombia that includes repatriation in case of disability or death.



**Monthly stipend:**  
ICETEX will support each foreign scholarship recipient with a monthly support of three minimum wages



**Books and materials:**  
**\$500.000 pesos**  
Colombian pesos will be awarded for books and supplies



**Installation costs:**  
**\$500.000 Colombian pesos**  
They will be granted in the first disbursement, only once, during the duration of the academic program.



**BENEFITS:**  
Applicants from non-Spanish-speaking countries may apply, with a duration of up to 8 months, for scholarships to perfect the Spanish language.

**Requirements:**

- Must be a foreign citizen
- Must not be of Colombian nationality
- Must not be residing, nor have resided the last 6 months prior to applying for the scholarship in Colombian territory or have started studies in Colombia at the time of applying to the corresponding call
- Applicants must present the Certificate of Migratory Movements
- Must not have any marital or de facto ties in Colombia
- Must not be older than 50 years
- Must not have started postgraduate studies in Colombia
- Have good physical and mental health, certified by a doctor.
- Can't have been a beneficiary through ICETEX of the Beca Colombia Scholarship program.
- Have a cumulative general average of 4.0 out of 5.0 in undergraduate to apply for the call. According to the rating scale of each country, the grade must be equivalent to at least 4.0 for the Colombian scale. \* It is not valid to present postgraduate averages.
- Must have a professional, undergraduate or bachelor's degree in any area of knowledge.
- Must have a minimum level in Spanish language of B2. If Spanish is not the grantee's native language, they must present a certification of the DELE or SIELE exam with a B2 level.
- Have definitive admission to at least one or up to three postgraduate programs that are in the Catalog of Academic Offer 2022 annexed to this call. In case the application is for a Spanish course, the admission of the institution offering the course will be required

**Courtesy Visa:**  
ICETEX will send letters to Colombian consulates abroad for the issuance of the courtesy Visa type "V" (visitor).

**Unforeseen costs:**  
This will be awarded for contingencies. This value will only be awarded once during the entire study program.
